(1) Classification: Grade B, Grade C, Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: It is a well written retrospective single center study highlighting the</p>	[Y]

possible influence of postoperative complications on long-term survival and the ability of the Comprehensive Complication Index to predict it, in liver transplant patients. Methods section should be clarified to match the study description, or the description should be revised. There are several grammatical and English mistakes. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 4 figures. A total of 24 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, Grade B, Grade B and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add the PMID and DOI in the reference list. Please

	<p>provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces; and (5) I found the language classification was grade C.
