The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript is well written and interesting. However,</p>	[Y]

the use of self-reports of physician-diagnosis of some disease conditions is a major drawback. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 47 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. The CONSORT 2010 Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: (1) The language classification is Grade C. Please provide the original figure documents. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing.
