2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the prognostic factor in gastrointestinal stromal tumors. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Reviewer#00504218 pointed out that authors assessed clinical and prognostic significance of CR8 protein</p>	[Y]

expression in GIST. They analyzed a large number of tissues with immunohistochemistry and found that there is a close relationship between the prognosis of GIST and expression of CCR8. This is a carefully done study and the findings are of considerable interest. However, a few minor revisions are listed below: 1) Table 1, numbers are inconsistent in tumor location; 2) Table 2, the title should be univariate and “multivariate” analyses. Reviewer# 03270412 pointed out that authors concluded that CCR8 is predictive biomarker. CCR8 could be only prognostic marker. We do not know this patient or metastatic or receiving any treatments; and (3) Format: There are 4 tables and 2 figures. A total of 44 references are cited, including 19 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by Edanz’s editing services was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The authors need to provide the original informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. The first author was born in 1989 (under 45 years). 5 Issues raised: (1) I

	<p>found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) the authors need to provide the original informed consent file. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, the relevant ethics documents, and the English Language Certificate, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
