The topic is within the scope of the WJGO. (1) Classification: Grade B, Grade C and Grade D; (2) Summary of the Peer-Review Report: Among rectal cancers, the neuroendocrine tumor is a rare type. So, this study is valuable in terms of including and analyzing as much as 132 patients with rectal neuroendocrine tumors. However, the</p>	[Y]

manuscript has lots of issues. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 2 figures. A total of 26 references are cited, no including references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B and Grade C. The language editing certificate was provided by editage.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form, Written informed consent. STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJGO.

5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text.
