2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a Randomized Clinical Trial of the skin closure with tissue adhesives vs subcuticular suture after robotic urogynecologic procedures. The topic is within the scope of the WJM. (1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: This is a very clear article showing a</p>	[Y]

statistically significant benefit of using tissue adhesives over sutures for skin closure, both in time saving and in cosmesis. This study is a RCT in an area where there are few and as such provides a useful addition to the literature in this area. Please discuss the significant differences from your previous clinical experience to the current results and of the above-mentioned potential bias. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables. A total of 15 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, the Clinical Trial Registration Statement, the CONSORT 2010 Statement, the written informed consent. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJM. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and

	<p>DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
