The topic is in the scope of WJH. (1) Classification: B C and D. (2) Summary of the peer-review report: This paper provided two interesting cases. This paper introduced a rare reconstruction method of hepatic vein with right lobe liver graft, which is helpful for clinical work. The author had reported</p>	[ Y ]

one case in the past, this time increase to two cases with the same technical method. The descriptions of the two cases in this paper were duplicated and should be simplified. There were a few spelling mistakes in the article. (3) Format: Three figures. Fifteen references were cited, including six references published in the last three years. Three self-citing articles. 2 Language evaluation: 3B. Language editing certificate was provided by a native English speaker. 3 Academic norms and rules: The authors provided CARE Checklist-2016. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The written informed consent was gave to patients prior to study enrollment. No academic misconduct was found in the Bing search. The CrossCheck investigation: The similarity index between this manuscript and the published ones is too high, which doesn't meet the publishing requirements. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has one published article in WJH.

**Editorial Office Director:** Recommend for potential acceptance. 1 Scientific quality: I have checked the comments written by the science editor. I basically agree with the science editor. The topic of living donor liver transplantation is in the scope of WJH. Reviewer 03021264 pointed out that this paper introduced a rare reconstruction method of hepatic vein with right lobe liver graft, which is helpful for clinical work. However, the questions raised by the reviewers should be answered. There are 3 figures in the
