(1) <b>Classification:</b> Grade B; (2) <b>Summary of the Peer-Review Report:</b> The authors have reported their clinical experience of advanced sarcomatoid hepatocellular carcinoma (SHC) successfully treated with nivolumab, their clinical experience provides significant clinical implications. although they made pathological diagnosis of SHC after many kinds of immunohistochemistry, they did not document enough rationale for pathological diagnosis of SHC. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 16 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language editing certificate was provided by editage. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please provide the original figure documents.
