The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: Reviewer#03252388 pointed out that the case is very interesting and the figures and photographs are excellent. some questions: 1) Please elaborate on the reason to do endoscopic therapy with cyanoacrylate injection; 2) The treatment should be solely by surgical approach; and (3) Format: There are 4 figures and no table. A total of 36 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, the the Copyright License Agreement, the Signed Informed Consent Form(s) or Document(s), and CARE Checklist-2016. No academic misconduct was found in the Bing search. The single sentence repetition rate of crosscheck reached 8%. 4 Supplementary comments: This is an invited manuscript. There is no fund support for this study. The topic has not previously been published in the WJG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not add all the PMID and DOI in the reference list. Please provide all the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "TREATMENT" section to the main text, according to the Guidelines and Requirements for

	<p>Manuscript Revision; (4) Please add some references. (5) Your manuscript has been checked by CrossCheck. Please read the attached CrossCheck report for details. Our editorial policy states the overlapped section should be less than 5% in single papers, including the author's own work. The authors need to rephrase these repeated sentences. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
