The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer#02520900 pointed out that the manuscript is well written, the introduction provides an excellent overview of the actual</p>	[Y]

literature, and the results are presented clearly and discussed and compared adequately with other studies. But the author should add a paragraph about the development of postmortem organ donation in Turkey in the recent 20 years. This can be presented as an outlook at the end of the discussion; and (3) Format: There are 2 tables and a figure. A total of 31 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form. The Copyright License Agreement requires all authors to sign manually. No academic misconduct was found in the Bing search. The single sentence repetition rate of crosscheck reached 5%. 4 Supplementary comments: This is an invited manuscript. This study is supported by Inonu University Scientific Research Projects Coordination Unit. The topic has not previously been published in the WJG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not add all the PMID and DOI in the reference list. Please provide all the PubMed numbers and DOI citation numbers to the reference list. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted. (Fang-Xin Fan)
