The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: This manuscript was well-written and documented. This manuscript gives additional new knowledge to the existing literature. This is an interesting case report. However,</p>	[Y]

there are some issues should be addressed. The authors need to add more details in the “case presentation” section. The authors failed to address some very important aspects in your report. The case report could be condensed a bit, and there are some dubious statements in the “Discussion”. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 22 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade C. A language editing certificate issued by MedE was provided. The language needs to be further improved. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 2016 PUMCH Science Fund for Junior Faculty. The topic has not previously been published in the WJCC. The corresponding author has published 2 articles in the BPG. This manuscript is the resubmission of Manuscript No. 50201. 5 Issues raised: (1) I found the language classification was grade C.
