The topic is within the scope of the WJCC. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: In this study, the clinical value of the needle-free sling was further analyzed. The design of the study is good, aims are clear. Inclusion and exclusion criteria are</p>	[Y]

reasonable and clear. Overall, the manuscript is well written; and (3) Format: There are 5 tables. A total of 20 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
