the presentation and the management of the disease. "Hydatid disease" and/or "Hydatidosis" could be added to the keywords list. The reviewer#02549888 thinks the operative steps need to be rewritten which will give a better perspective of the case. The discussion section should include references of similar cases. (3) Format: There are 2 figures. A total of 12 references are cited, including 4 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Chunfenglv was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance.(Han Zhang)
