scope of the WJG. (1) Classification: Grade A and Grade A; (2) Summary of the Peer-Review Report: Reviewer# 00050424 thinks this is a well-written and comprehensive article. The study is well designed and the results are clear. The authors need to add data from previous studies on the efficacy of this herbal on other types of hepatitis b infection. Reviewer# 00071703 summarized the authors aimed to evaluate the feasibility and safety profiles of a Chinese as a therapeutic option for chronic HBV infection. They have concluded that the ability of the compound to modulate host immune function probably contributed to this effect. This manuscript is well written; the figures and the tables are all appropriate. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 7 figures. A total of 54 references are cited, including 9 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade A. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the Institutional Review Board Approval Form, informed consent, CONSORT Checklist, Clinical Trial Registration Statement. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously

been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
