The topic is within the scope of the WJG. (1) Classification: 2C. (2) Summary of the peer-review report: The paper is interesting, however there are some points that may be clarified before the publication. The number of training set samples and the number of validation samples is too little and should be</p>	[Y]

increased. (3) Format: 3 table and 7 figures; 12 supplementary figures. 24 references were cited, including 10 references published in the last 3 years. 3 self-citing articles. 2 Language evaluation: 2B. Language editing certificate was provided by enago. 3 Academic norms and rules: The authors provided biostatistics review certificate and STROBE statement. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was provided. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Supported by two the National Natural Science Foundation of China; the Science Foundation of Hunan Health Commission. (3) Corresponding author has not published articles in the WJG.

Editorial Office Director: 1 Scientific quality: This manuscript describes a case control study of establishment of a pattern recognition metabolomics model for diagnosis of hepatocellular carcinoma, and it is within the scope of the WJG. (1) Classification: Grade C, and Grade C; (2) Summary of the Peer-Review Report: Reviewer 02562387 thought that the main results obtained by the authors was the definition of two models based on the metabolomes of three group of patients. From the scientific point of view, these findings might have certain relevance, however the level the evidence achieved was not enough to consider that the results described were robust enough for being applied in a clinical

context. Reviewer 03017752 thought that the authors based on pattern recognition method and ultra-performance liquid chromatography-mass spectroscopy to characterize the serum metabolome of patients with hepatocellular carcinoma and cirrhosis, followed by sequential feature selection combined with linear discriminant analysis to process the multivariate data. The paper was interesting, however there were some points that may be clarified before the publication. Overall the authors need to make major revision according to both of reviewers' comments. And (3) Format: There are 3 tables and 7 figures. A total of 24 references are cited. There are 3 self-citations. 2 Language quality: Classification: Grade B, and Grade B. The authors have provided the "Non-Native Speakers of English Editing Certificate". 3 Academic norms and rules: The Conflict-of-Interest Disclosure Form, Institutional Review Board Approval Form, Informed Consent Form(s), STROBE Statement, and Copyright License Agreement files are complete and qualified. The results of Bing search and CrossCheck detection are eligible. 4 Supplementary comments: This is an unsolicited manuscript. Three financial supports were obtained for this study. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Article Highlights” section is missing.
