The topic is within the scope of the WJO. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: The authors reported an impressed study, but some</p>	[Y]

grammar/typo issues should be revised; and (3) Format: There are 3 figures. A total of 62 references are cited, including no references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form and the Written informed consent. The Biostatistics Review Certificate, the Conflict-of-Interest Disclosure Form and the Copyright License Agreement are not right. The CONSORT 2010 Statement lacks of the page number under each items. No academic misconduct was found in the Bing search and CrossCheck. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (5) An informative, structured abstract of no less than 350 words should accompany the manuscript. Abbreviations should be avoided, but if used should be spelled out at first mention. The 5

	<p>sections of the structured abstract are: Background, Aims, Methods, Results, and Conclusion. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. There are no references published in the last 3 years. The authors need to update the references.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
