2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the MDT in metastatic choriocarcinoma. The topic is within the scope of the WJCC. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The content of the paper is a rarity in the field of oncology. The contribution is interesting, a rarity in the treatment of patients with</p>	[Y]

choriocarcinoma is presented. A summary table for the case is recommended to describe demographic data, physical laboratory and imaging data. Figures with a high resolution for lung computed tomography and spinal magnetic resonance imaging are mandatory and it is preferable to use arrows for clarification. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 10 references are cited, including 3 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Clarity Manuscript Consultants was provided.

3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. The authors need to fill out the CARE checklist form with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG.

5 Issues raised: (1) I found the title was more than 20 words. The title should be no more than 20 words; and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor.
