The topic is within the scope of the WJGS. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: The case is interesting, and it deserves publication, as it describes a rare complication of enteral feeding. However, there are some issues should be addressed. Writing style needs to be more concise. A table with</p>	[Y]

prior case series summarized would be helpful to the reader. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 10 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade C. The language needs a great deal of polishing. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGS. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please provide the author contributions; (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the

Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision; and (6) the author should number the references in Arabic numerals according to the citation order in the text.
