The topic is within the scope of the WJCO. (1) Classification: B and C. (2) Summary of the peer-review report: The study is well performed and nicely written</p>	[Y]

and presents a large, single center experience on different adjuvant therapy regimens in resected pancreatic cancer. It is well designed and well discussed. (3) Format: 5 table and 3 figures. 30 references were cited, including 11 references published in the last 3 years. No self-citation. 2 Language evaluation: B and C. The authors declared that all authors reviewed this article. 3 Academic norms and rules: The authors provided biostatistics review certificate. The authors should provide the STROBE statement with line/page. The authors signed the conflict-of-interest disclosure form. The authors should provide integral copyright license agreement. The institutional review board approval form was uploaded. The written informed consent was waived. No academic misconduct was found in the Bing search. The CrossCheck investigation: The similarity index between this manuscript and the published ones is too high, which doesn't meet the publishing requirements. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in the WJCO. 5 Issues raised: The major weakness of the study lies on the language limits and a big confusion in the organization of results' description.

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is the adjuvant therapy for pancreatic cancer, and is within the scope of the WJCO. (1) Classification: Grade B, and Grade C; (2) Summary of the

Peer-Review Report: Reviewer#03091510 thinks this is a large single-centre study. The authors correctly acknowledge the limitations of their study. The study is well performed and nicely written and presents a large, single center experience on different adjuvant therapy regimens in resected pancreatic cancer. Reviewer# 02543905 pointed out this paper deals with an open problem in oncologic surgery, it is well designed and well discussed. The number of patients is large enough to drive some conclusion with the obvious limit of the retrospective design. The major weakness of the study lies on the language limits and a big confusion in the organization of results' description. Reviewer thinks this is an overall valuable study; and (3) Format: There are 5 figures and 3 tables. A total of 30 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, Copyright License Agreement, Biostatistics Review Certificate, and Institutional Review Board Approval, all of which are qualified. The authors stated that patients were not required to provide informed consent for this study because the analysis used anonymous clinical data that were obtained after patient had agreed to treatment with written consent. No academic misconduct was found in the Bing search. CrossCheck detection is not qualified (similarity 29%), the authors need to rephrase these

The authors should provide the grant application form(s). 5 Issues raised: (1) The authors need to provide editable figures; (2) The authors need to write the “article highlight” sections; (3) The authors need to add the PMID and DOI in the reference list. 6 Recommendation: Conditionally accepted.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
