The topic is within the scope of the WJSC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors compared the</p>	[Y]

effects of two cell transplantation therapies on the treatment of spinal cord injury. And the simple study clarified the effectiveness of the two cell transplantation strategies and compared the results with a preliminary one, which is of great significance. However, there are still some issues that need to be revised. So the questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 9 figures. A total of 29 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language was checked by Papercheck team. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, and the Institutional Review Board Approval Form. The Copyright License Agreement lacks of the signature. The Institutional Animal Care and Use Committee Approval Form or Document and The ARRIVE Guidelines are not qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The manuscript is supported by 1 grant. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The running title, authors' information, corresponding author's information, and "Author Contributions" section are missing. Please provide them; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list.
