The reviewer#05086666 thinks the major issue of this review is with lack of adequate referencing of relevant literature and suggests that the author should revise the whole manuscript. (3) Format: 6 figures and 4 tables. 81 references were cited, including 54 references published in the last three years and 6 self-citations. 2 Language evaluation: A and B. The authors declare that the corresponding and primary author who has prepared this manuscript is a native speaker of English and the authors have utilized a paid editing service from Grammarly® and ProWritingAid™ for finalizing the manuscript. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support.
