The topic is within the scope of the WJBC. (1) Classification: Grade B, Grade C, and Grade D; (2) Summary of the Peer-Review Report: The manuscript highlights the methods and materials used in recent studies to investigate the expression of</p>	[Y]

GLUT4 in the skeletal muscle, adipose tissue, heart and brain. The review is interesting but reviewer requires some changes: The part concerning "Carbohydrate digestion and absorption" could be eliminated; All descriptions relating to the search in pubmed could be deleted; All tables must be more concise because in the current form they are difficult to read; Reduce the introduction and, please, highlight the innovative content as this transporter is often revised; and (3) Format: There are 6 tables and 2 figures. A total of 162 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B, and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJBC. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the

	<p>sentence with the citation content or after the cited author's name, with no spaces; (4) All figures, and tables should not be in the main text.
