2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a clinical and translational research of the overexpression of AMPD2 protein is a prognostic risk factor for colorectal cancer patients via Notch3 signaling pathway. The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: The reviewer#00503405 thinks the study is well designed, well documented and well presented.</p>	[Y]

The results are clear, precise and logical but the discussion is too short, more perspectives (therapeutic possibilities) must be discussed. English language needs minor polishing. The reviewer#02744973 thinks the study is very interesting. However due to several language errors the paper is quite difficult to read. The authors used several studies but the reference is only 1. The introduction could be shortened and a limitation of the study section needs to be included. (3) Format: There are 3 figures and 2 tables. A total of 18 references are cited, including 6 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A, Grade B and Grade D. A language editing certificate issued by Mogo Edit was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the Institutional Review Board Approval Form. The authors did not sign the Copyright License Agreement and the Conflict-of-Interest Disclosure Form. The Signed Informed Consent Form, the CONSORT 2010 Statement and the Clinical Trial Registration Statement were not provided. Result of Bing search is eligible, but the CrossCheck result showed the similarity to be high (single 12%). 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the grant from Wuxi Young Medical Talents, Jiangsu province, China. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The authors did not provide the approved grant application form(s). Please
