The authors should provide parathyroid hormone and magnesium levels in order to exclude hypoparathyroidism as a cause for APN and explain the reason of</p>	[Y]

that the chronic hepatitis (139) is a risk factor for APN. (3) Format: There are 2 figures and 1 table. A total of 11 references are cited, including 1 reference published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B. The primary author is a native speaker of the English language. 3 Academic norms and rules: The authors provided the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. The Signed Informed Consent Form was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Research Foundation. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) PMID and DOI numbers are missing in the reference list.
