The topic is within the scope of the WJG. (1) Classification: Grade B and Grade B; (2) Summary of the Peer-Review Report: Reviewer#04913257 pointed out this study fully addresses an</p>	[Y]

interesting and quite challenging topic. There is no strong evidence regarding the choice of the route to perform the transplant, however, the method proposed by the authors according to the results sounds as a favorable option and according to what patients have commented, widely tolerated. Reviewer#03478404 thinks the general conclusion of the study is that patients require important education regarding FMT and TET. The manuscript is easily to be followed, contains accurate data, has a high scientific quality and represents an important tool for physicians and their patients. However, there are some points need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 27 references are cited, including 15 references published in the last 3 years. There are 13 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. The authors provided a personal language certificate. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the signed Copyright License Agreement. The authors need to complete the Conflict-of-Interest Disclosure Form, and to add the page number in the STROBE Form. The authors need to provide the original Institutional Review Board Approval Form and written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Public Donated Intestine Initiative Foundation; and Jiangsu Province Creation Team
