The risk of performing colonoscopy after 80 years old (including polypectomy when is necessary) should be discussed. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 23 references are cited, including 9 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editing Synthase was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and informed consent. The STROBE form should be added the page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Cancer Center, Korea. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor;</p>
