Please provide the DOI numbers for all the references if available. (3) Format: There are 3 figures and 2 tables. A total of 23</p>	[Y]

references are cited, including 9 references published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade A. The authors are native speakers of English. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and the PRISMA 2009 Checklist. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was without financial support. The topic has not previously been published in the WJH. 5 Issues raised: (1) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-review: Not required. 7 Recommendation: Conditional acceptance. (Han Zhang)
