The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The reviewer#02467870 thinks this is a report of development of a new and interesting robot system designed for interventional pain therapies. commended for their innovative approach to this emerging technology. Few words and units are not used properly and should be revised. In regarding to the limitations of the study, the authors recognize that head movement during clinical practice will pose a major challenge to the application of this approach and to this system. (3) Format: There are 5 figures and 2 tables. A total of 27 references are cited, including 15 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. The Institutional Animal Care and Use Committee Approval Form, the Institutional Review Board Approval Form and the ARRIVE Guidelines were not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Key R & D project in Jiangsu province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can
