2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a retrospective cohort study of the acute abdominal pain. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study is a single-institutional retrospective review of 522 patients with liver cancer treated with transarterial chemoembolization. This article is interesting and well written. Actually, their work does not</p>	[Y]

contribute to improved prognosis of patients, but the evaluation of quality of life is an important issue. It will give useful information to physicians. However, there are some problems that the authors should clarify and revise. The authors need to add more details in the “method” section. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 26 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by ELIXIGEN was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Medical Health Science and Technology Project of Zhejiang Provincial Health Commission. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
