<b>2</b>	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 <b>Scientific quality:</b> The manuscript describes a case report of duodenal giant stromal tumor combined with ectopic varicose hemorrhage. The topic is within the scope of the WJCC. (1) <b>Classification:</b> Grade C and Grade C; (2) <b>Summary of the Peer-Review Report:</b> In the manuscript, the authors have reported a case of duodenal GIST with ectopic varicose hemorrhage. This is a rare case of duodenal GIST with uncontrollable bleeding due to varicose veins for which an emergency surgery was needed. This</p>	[ Y]

case report would provide useful clinicopathological information to the journal's readers, there are some comments to be addressed. Pathological findings of postoperative specimens need to be moved to the "Final diagnosis" section or describe them in a new section. The author should discuss more about endoscopic techniques other than applying metal clips to stop bleeding in cases of duodenal varicose hemorrhage. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 11 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Signed Informed Consent Form, and the CARE Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the

	<p>editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the authors need to provide an editable manuscript (format: .doc or .docx). 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
