	<p>not provide a background on the pathology being described in the manuscript. There are some issues should be addressed. The authors need to add more details in the “Case presentation” section. Therefore, I suggest transfer to the World Journal of Clinical Cases.</p> <p>Editorial Office Director: I have checked the comments written by the science editor. I suggest that the manuscript should be transferred to the WJCC.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
