endoscopy. The recommendations are clinically useful and will potentially be of interest to a wide number of clinicians.; and (3) Format: There are 1 table. A total of 17 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade A. The authors are all Americans. 3 Academic norms and rules: The authors provided the signed Copyright License Agreement. Conflict-of-Interest Disclosure Form should be signed by corresponding author. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The corresponding author has not previously published articles in the WJGS. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.

Editorial Office Director: 1 Scientific quality: I have checked the comments made by the science editor, and I basically agree with the science editor. The topic of the paper is within the scope of the WJGS. (1) Classification: Grade A, and Grade C; (2) Summary of the Peer-Review Report: Reviewer 00057659 summarized that this is a very interesting manuscript which underlines the guidelines of the

ASC and gives advices for daily work under this special circumstances. Reviewer 03884279 summarized that this article provided useful practice recommendations on surgery with endoscopy; and (3) Format: I have checked the manuscript, and I agree with the science editor. 2 Language evaluation: The authors are native English speakers. 3 Academic norms and rules: I have checked the documents, including the Conflict-of-Interest Disclosure Form, and Copyright License Agreement, all of which are qualified. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for this study. 5 Issues raised: (1) I found that the author contributions is missing. Please provide the author contributions; (2) I found the core tip section is missing. Please write the “core tip” section behind of the key words; (3) I found the PMID numbers are missing in the reference list. Please provide the PubMed to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditionally accepted.
