The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade C and Grade D; (2) Summary of the Peer-Review Report: The study is interesting since it provides information on a rare form of neoplasm. The manuscript is about</p>	[Y]

a brain tumour in which a rare histopathological result was observed. Yet, the flow-chart of the manuscript does not let the readers to discuss about the differential diagnosis. The figures need annotations, scale bar, color blindness safe mode, magnifications, and insets. Language needs polishing. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 16 references are cited, without references published in the last 3 years. The authors need to update references. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Natural Science Foundation of Anhui Medical University. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) I found the authors did not provide the original figures. Please provide the original figure documents.
