There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. The language editing certificate is not provided, but the author said that he was born in the United States. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License AgreementNo academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJO. 5 Issues raised: (1) The short title, authors' information, corresponding author's information and core tip should be added in the first page of the manuscript. (2) The "Author Contributions" section is missing. Please provide the author contributions. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript and the relevant ethics documents, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions. For citations where no author is indicated, a superscript number should be placed at the end of the sentence.
