The topic is within the scope of the WJCO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors described the evaluation of the co-expression of FOXP3</p>	[Y]

and IDO biomarkers in TNBC, which is potentially interesting but it requires major and minor revisions, especially many data presentations and the discussion section need to be revised. The questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 35 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The Written informed consent was not right. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Shaukat Khanum Memorial Cancer Hospital and Research Centre, Lahore, Pakistan. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The “Article Highlights” section is missing.
