HE stain and immunohistochemistry. The reviewer gave some detailed suggestions of revision; and (3) Format: There are 3 figures. A total of 13 references are cited, including 6 references published in the last 3 years. There are 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. But the written informed consent was not provided. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required/Not required. 7 Recommendation: Conditional acceptance.
