also describe his genetic diagnosis history. The article is very interesting and little describing in literature. The iconography is well represented. However, there are some issues should be addressed. The manuscript overall is too long and should be shortened. The language editing is poor to the degree of confusion. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 31 references are cited, including 4 references published in the last 3 years. The authors need to update the references. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B, Grade B and Grade C. Although the authors provided a language certificate by professional language company, the language needs to be further improved.

3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the informed consent. The authors need to fill out the CARE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search.

4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; Fujian Province Medical Innovation Foundation; and the Science and Technology Project of Fujian Province. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG.
