(1) Classification: Grade B; (2) Summary of the Peer-Review Report: This study was compared the effect of smartphone-based interventions and monitoring with control methods in treating patients with bipolar disorder. well written overall. Also, this study is very interesting. If the author makes a few changes, the quality of the study will be higher. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 7 figures. A total of 45 references are cited, including 17 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide the Biostatistics Review Certificate and PRISMA checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Anhui Natural Science Foundation; the project of human social science of Anhui province; and Grants for Scientific Research of BSKY from Anhui Medical University. The topic has not previously been published in the WJP. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight”
