The topic is within the scope of the WJO. (1) Classification: Two Grades C; (2) Summary of the Peer-Review Report: This is an interesting manuscript about the comparison of patient reported outcome,</p>	[Y]

infection eradication rate, and complications between functional articulating spacers and prefabricated spacers used in two-staged revision arthroplasty for a periprosthetic joint infection of the hip. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 18 references are cited, including 5 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. No language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main
