(1) Classification: Grade B; (2) Summary of the Peer-Review Report: The reviewer#05306123 thinks the authors are able to manage a patient from devastating outcomes by keen early observation and</p>	[ Y]

immediate definite planning. The details of ultrasonography and liver enzymes (esp. ALP) should be mentioned in preoperative period. The reason of doing MRI needs explanation. The authors could explain what made them choose laparoscopic re-exploration over trial of ERCP. (3) Format: There are 2 figures. A total of 9 references are cited, including 1 reference published in the last 3 years. There is no self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by International Science Editing was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent Form and the CARE Checklist-2016. The authors signed the Conflict-of-Interest Disclosure Form and the Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China, the Jiangsu Key Medical Talents Fund, the Natural Science Foundation of Liaoning Province and the Dalian Medical Science Research Project. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The title is too long, and it should be no more than 12 words; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of
