| Patient Information | 6a | De-identified demographic and other patient or client specific information | <u>22-25/5</u> |
| | 6b | Chief complaint—what prompted this visit? | <u>22-25/5</u> |
| | 6c | Relevant history including past interventions and outcomes | <u>6-7/6</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>12-13/6</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>15-24/6</u> |
| | 8b | Diagnostic reasoning including other diagnoses considered and challenges | <u>20-24/6</u> |
| | 8c | Consider tables or figures linking assessment, diagnoses and interventions | <u>15</u> |
| | 8d | Prognostic characteristics where applicable | <u>13-26/7</u> |
| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>4-9/7</u> |
| | 9b | Intervention administration such as dosage, frequency and duration | <u>27-29/7</u> |
| | 9c | Note changes in intervention with explanation | <u>27-29/7</u> |
| | 9d | Other concurrent interventions | <u>27-29/7</u> |

| Informed Consent | 13 | Informed consent from the person who is the subject of this case report is required by most journals | <u>20-22/14</u> |
| Additional Information | 14 | Acknowledgement section; Competing Interests; IRB approval when required | <u>24-25/14</u> |
