2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the acute pancreatitis. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer#03310785 thinks this is an interesting study, but there are some points need clarifying and certain statements require further justification. The authors need to describe the details of PSGL-1/- mice. The manuscript contains multiple errors in English</p>	[Y]

writing. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 35 references are cited, including 16 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. Although the authors provides the language editing certificate issued by AJE, the language needs to be further improved. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, the Institutional Review Board Approval Form, and ARRIVE checklist Form. The authors need to complete the Conflict-of-Interest Disclosure Form, and to provide the Institutional Animal Care and Use Committee Approval Form. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. The authors need to rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China, and Chinese Academy of Medical Sciences Innovation Fund for Medical Sciences. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. The first author was born in 1990 (under 45 years old). 5 Issues raised: (1) I found there is no "Author contribution" section. Please provide the author contributions; (5) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval

document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (5) The author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; and (6) co-first author or co-corresponding author is not allowed. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.

Editorial Office Director: I have checked the comments written by the science editor. I suggest a re-review for the revision.
