2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the five-year survival of combined hepatocellular and cholangiocarcinoma. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This manuscript has evaluated factors associated with 5-year survival of combined hepatocellular and cholangiocarcinoma. and clear to the reader. The authors should add in the discussion that it is not possible to retrieve from SEER data concerning laboratory exams that may have an impact on 5-year survival. Moreover, authors need to discuss the limitation of this study. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 36 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The manuscript is from the United States. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. This study used publicly available database without interaction with individual patients, therefore informed consent and the Institutional Review Board Approval Form were not required to conduct this study. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
