(1) Classification: Grade B; (2) Summary of the Peer-Review Report: Good case report. Useful to the practicing clinicians. The content of the discussion is quite good. However, a few corrections are essential with respect to proper citations of references. The findings in the reported cases need to be discussed</p>	[Y]

in comparison to the cited articles. This will add to the authenticity of the report. Conclusion should be changed to include a comprehensive inference and pearls of wisdom for clinicians. The questions raised by the reviewers should be answered; and (3) Format: There are 2 figures. A total of 9 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
