Peer-Review Report: The authors investigated the DNA methylation levels in GNAS locus in pancreatic cysts. The authors found methylation changes at 4 regions in this locus that were related to clinical factors. The content of the manuscript is interesting. However, the questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 1 figure. A total of 20 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade C. A language editing certificate was not provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the written informed consent. The STROBE Statement lacks of the page number. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The language classification is Grade C. Please provide the original figure documents.
