application of herbs or the development of novel therapies for the management of oxidative stress-related diseases. Very interesting study. And the manuscript is well written. The experiment of the study is designed very well, aims are very clear. Methods are reasonable. Data in figures and tables are very good, and well discussed. The results are excellent, but not very clear. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 45 references are cited, including 9 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by Wiley was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Animal Care and Use Committee Approval Form, and the ARRIVE guidelines. The study does not involve humans. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the
