tests for specificity and sensitivity in China (Wuhan). The study is very important considering current situation with ongoing situation worldwide. However, there are some issues should be addressed. It is essential to report all catalog numbers for the used antibodies/detection kits described in this study. The tests may be requested and repeated by other scientists worldwide. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total of 20 references are cited, including 20 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and the informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Natural Science Foundation of Hubei Province; and Wuhan City Medical Research Project. The topic has not previously been published in the WJCC. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not write the “article highlight” section.
