prospective dataset. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 48 references are cited, including 20 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form and the written informed consent. The authors indicated this study is not a clinical trial, therefore the CONSORT form and clinical registration statement are not applicable. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study is without financial support. The topic has not previously been published in the WJG. This manuscript is a resubmission of manuscript 55293. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the authors did not write the "article highlight" section. Please write
