The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: This study is very useful and well written. The authors ran a study in a specific time of the world which there is a need for such an investigation. The findings are original and novel, and many</p>	[Y]

readers will refer to this study in the future. However, there are some issues should be addressed. Obviously, there were many other factors that were overlooked or were not possible to be added to this study. There can be added to the limitations of the study. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables. A total of 23 references are cited, including 9 references published in the 2020. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editideas was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the informed consent. The authors need to complete the Conflict-of-Interest Disclosure Form and provide original Institutional Review Board Approval Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Xiamen Children's Hospital Backbone Talent Training Program Project. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original

figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (5) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; and (6) The authors need to complete the Conflict-of-Interest Disclosure Form and provide original Institutional Review Board Approval Form. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.
