2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the Helicobacter pylori infection with atrophic gastritis. The topic is within the scope of the WJG. (1) Classification: Grade A, Grade C and Grade D; (2) Summary of the Peer-Review Report: Reviewer# 00052643 thinks this is an interesting paper. This manuscript is well-designed and sample size</p>	[Y]

is wide. Reviewer# 00068978 thinks this study holds some scientific merit. However, there are some minor comments that need to be addressed. The authors need to describe more details in the method section. The language needs a great deal of polishing. Reviewer# 03733959 pointed out this research studied the correlation between *Helicobacter pylori*, atrophic gastritis and colorectal adenomas. However, there are some points need to be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 31 references are cited, including 2 references published in the last 3 years. The authors need to update the references. There are no self-citations.

2 Language evaluation: Classification: Grade A, Grade B and Grade C. The authors need to provide the language certificate of professional language company. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to provide the official Institutional Review Board Approval Form of Chinese version, and original informed consent. No academic misconduct was found in the Bing search. The CrossCheck results showed the similarity to be high. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in

the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the language classification was grade C. Please visit the following website for the professional English language editing companies we recommend: <https://www.wjgnet.com/bpg/gerinfo/240>; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (4) The authors need to provide the official Institutional Review Board Approval Form of Chinese version, and original informed consent. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.

Editorial Office Director: I have checked the comments written by the science editor. All of the three reviewers require a re-review.

Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
