been several published papers on discussing PEP, they mostly focused exclusively on types of medication, timing or route of administration. The authors made explicit analysis on all these topics in the same article. They also included only RCT data which made the results more robust. One major concern is that authors may not need to discuss the dosage of each NSAID. Comparing different medications with same dose category doesn't make any sense. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 7 figures. A total of 38 references are cited, including only 1 reference published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG. This manuscript is the resubmission of Manuscript No. 38555 (Rejected). 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all
